Town/parish taxbase (gross)	267.82	This is the number of properties in the town/parish who pay Council Tax, converted to Band D equivalents
Local Council Tax Support discounts	-10.64	This is the number of properties who receive an LCTS discount in 2024/25, converted to Band D equivalents
Town/parish taxbase (net of LCTS discounts)	257.18	This is the actual taxbase that is used to calculate the Band D council tax.
Town/parish precept for 2024/25	£20,250.00	This is the 2024/25 precept set by your town/parish council.
