

## ITEM 7.4 on Agenda for 9 February 2023

### GRANTS

Original budget 2022-23 £2,800. £1,500 of the budget was transferred to cover spending on the planning appeal leaving £1,300 remaining in budget (see minutes dated 9 June 2022, item 22/06-7.10).

\*Could make grant to 5 parishes mag under s142 LGA 72 as this carries publicity/info about the parish council, but s142 expend is limited by s137(2C) and s137(2D) – money spent on publicity under s142 will count towards the s137 limit.

Can fund publicity under s137(2C)(b) LGA 72 – assistance to a public body or voluntary org where the publicity is incidental to the main purpose for which the assistance is given.
